IMPORTANT NOTICE:

This End User License Agreement ("Agreement") is a legal agreement between you ("user", "you", and "your") and tinyBuild LLC ("tinyBuild", "us", "we", and "our") for The Deadside Mod Kit (Console Edition) ("Licensed Material") for our game, Deadside (the "Game"). By installing, accessing, or using the Licensed Material, you agree to be bound to the terms and conditions of this Agreement. If you do not agree to the terms, you must not install and use the Licensed Material. The Licensed Material and any accompanying online or electronic documentation has been produced by and is the property of tinyBuild.

Use of the Editor (defined below) is subject to the Unreal Engine End User License Agreement ("UE EULA"), which may be found at www.unrealengine.com/eula. By downloading or using the Editor, you also agree to the UE EULA. Use of the Epic Marketplace (defined below) is subject to Epic's Terms of Service, which may be found at <https://www.epicgames.com/site/tos>. By using the Epic Marketplace, you also agree to Epic's Terms of Service.

The purchase, download, installation, and use of the Licensed Material is subject to our Privacy Policy ("Privacy Policy") located at <https://www.tinybuild.com/privacy-policy> and Terms of Use ("TOU") located at <https://www.tinybuild.com/tou>.

Electronic transactions and communications are used for all interactions with us. By accepting this Agreement, you consent to transact with us electronically. This Agreement remains effective until terminated by either you or us.

1. YOUR USE OF THE LICENSED MATERIALS 1.1 Age Confirmation. By downloading and installing the Licensed Material, you confirm that you are an adult of the legal age in your country or have permission from your parent or guardian. If you are under the legal age, your parent or guardian must agree to these terms. You and your parent or guardian are responsible for all actions related to your account. Providing false information about your age or consent is against our rules and can lead to losing access to the Licensed Material. We comply with relevant privacy protection regulations, including but not limited to the Children's Online Privacy Protection Act ("COPPA"), the General Data Protection Regulation ("GDPR"), and the California Consumer Privacy Act ("CCPA") and do not knowingly collect personal information from children under 13. If we learn that we have collected personal information from a child under 13, we will take prompt steps to delete such information. Providing false age information is a violation of this

Agreement and may result in termination of access to the Licensed Material. If you are a parent or guardian and discover that your child has provided us with personal information without your consent, please contact us immediately at privacygroup@tinybuild.com.

1.2 System Requirements. You are responsible for ensuring that your device meets the minimum system requirements necessary to download, install, and use the Licensed Material. You are also responsible for ensuring that you are using the latest compatible public release of any platform or operating system required to use the Licensed Material. We are not responsible for any issues, errors, or damages that may arise from your failure to comply with these requirements.

2. OWNERSHIP OF THE LICENSED MATERIAL

2.1 License Grant for the Licensed Material. We grant you a non-exclusive, personal, revocable, non-transferable license to download, install, and use the Licensed Material for your personal, non-commercial use on devices you own or control, provided they meet the necessary specifications, to create and develop a Mod. You agree that your use of the Licensed Material is solely for personal entertainment and has no monetary value.

2.2 License Grants for Mods. 2.2.1 tinyBuild grants you a limited, revocable, royalty-free, non-transferable, non-sublicensable (except as required to publish your Mod), non-exclusive right and license to use, display, and publish the Mod that integrates our Content. Your license to use our Content to create the Mod will automatically terminate without further notice to you upon the termination or expiration of this Agreement.

2.2.2 You own your Mod, but by uploading or sharing the Mod with tinyBuild, you grant us a non-exclusive, irrevocable, perpetual, royalty-free, transferable, sub-licensable, worldwide license to use, host, distribute, modify, run, copy, publicly perform or display, translate, and create derivative works of your Mod without compensation to you.

2.2.3 If you remove the Mod from the Licensed Material, tinyBuild may retain copies of your Mod for archival and its own further exploitation. You hereby grant to each user who downloads your Mod a non-exclusive, royalty-free license to use one copy of your Mod on a device solely for the user's personal entertainment. You agree that after downloading your Mod, the user may continue using your Mod even after you remove your Mod from the Licensed Material.

2.3 License Conditions. 2.3.1 You may not do any of the following with respect to the Licensed Materials or any of its parts: (a) use it commercially; (b) copy, reproduce, distribute, display, or use it in a way that is not expressly authorized in this Agreement; (c) sell, rent, lease, license, distribute, or otherwise transfer it; (e) reverse engineer, derive source code from, modify, adapt, translate, decompile, or disassemble it or make derivative works based on it; (f) remove, disable, circumvent, or modify any proprietary notice or label or security technology included in it; (g) create, develop, distribute, or use any unauthorized software programs to gain advantage in any online or other game modes; (h) use it to infringe or violate the rights of any third party, including but not limited to any Intellectual Property Rights, publicity, or privacy rights; or (i) use, export, or re-export it in violation of any applicable law or regulation.

2.3.2 In no event may Mods be illegal, fraudulent, deceptive, offensive, obscene, threatening, defamatory,

invasive of privacy, or infringing of intellectual property rights, or contain software viruses or other malware, as determined by tinyBuild LLC in its sole discretion.

2.3.3 Furthermore, with regards to Mods, while you are permitted to reference cooked content which is distributed with the Software, your Mod may not actively redistribute such content.

2.3.4 You acknowledge and agree that you are solely responsible and liable for any Mod you create or post. By posting any Mod, you represent and warrant that: (i) you own or have a license to post your Mod and all its constituent elements or are otherwise legally entitled to post the Mod; (ii) the Mod is accurate and truthful; and (iii) use of the Mod does not violate the terms of this Agreement and will not cause injury to any person or entity. You further acknowledge and agree that you will indemnify tinyBuild and its affiliates and third-party developers against all claims resulting from any Mod or other content or information that you supply, provide, or transmit to tinyBuild or its affiliates or third-party developers.

2.3.5 tinyBuild has the right, but not the obligation, to monitor and edit or remove any activity or Mod from its services.

2.3.6 Notwithstanding the terms of the UE EULA, you may not use the Editor or any Epic Content (a) with or in connection to any games, projects, products, or services other than the Game, or (b) to create or develop any separate or standalone games, projects, products, or services. Your breach of the foregoing will constitute a material breach of both the UE EULA and this Agreement. If you have entered into the UE EULA, then upon termination of this Agreement, your license under the UE EULA to use the Editor or Epic Content will immediately terminate; provided, however, that such termination will not terminate any license you may have under the UE EULA with respect to your use of other versions of the Unreal® Engine.

2.4 Proprietary and Intellectual Property Rights. The Licensed Material and Content are the Intellectual Property Rights of tinyBuild and are protected by copyright law, international copyright treaties, and other laws. All rights are reserved. The Licensed Material may contain certain licensed materials, and our licensors may protect their rights in the event of any breach of this Agreement. All trademarks are the property of their respective owners.

2.5 Trademarks. The tinyBuild logo, name, and all graphics contained in our Licensed Material are trademarks of tinyBuild or our affiliates and partners. Except as otherwise stated in this Agreement, nothing contained in our Licensed Material should be understood as granting you a license to use any of our trademarks, service marks, logos, or any of our other Intellectual Property Rights. Use, reproduction, copying, or redistribution of any of our Intellectual Property Rights, without our prior written permission is prohibited. All trademarks or service marks appearing on or in our Licensed Material that are not owned by us are the marks of their respective owners.

3. EDITOR

Notwithstanding the terms of the UE EULA, you may not use the Editor or any Epic Content (a) with or in connection to any games, projects, products, or services other than the Game, or (b) to create or develop any separate or standalone games, projects, products, or services. Your breach of the foregoing will constitute a material breach of both the UE EULA and this Agreement. If you have entered into the UE EULA, then upon termination of this Agreement, your license under the UE EULA to use the Editor and any Epic Content will immediately terminate; provided, however, that such termination will not terminate any license you may have

under the UE EULA with respect to your use of other versions of the Unreal® Engine.

4. TERM AND TERMINATION 4.1 Agreement Effectiveness. This Agreement, and any license granted by it, is effective upon your download, installation, and/or use of the Licensed Material and remains effective until terminated by either party.

4.2 User Termination. You may terminate the Agreement at any time by deleting and removing all copies of the Licensed Material and Content from the devices on which you have installed it and destroying your copy of the Licensed Material and Content in your possession.

4.3 Automatic Termination. The Agreement and any license granted by it will terminate automatically if you fail to comply with any term or condition. Upon termination, you will be notified and must cease all use of the Licensed Material, immediately delete all copies, and confirm compliance with these actions if requested.

5.2 Information Collection & Usage. You understand and agree that your information may be transferred or used in countries with lower privacy protection standards.

5.3 Data Privacy. All data privacy practices, including our collection, use, disclosure, and transfer of your personal information, are subject to our Privacy Policy (<https://www.tinybuild.com/privacy-policy>), which takes precedence over any other statement in this Agreement. If you do not want your information used or shared as described, do not install or use the Licensed Material.

6. LIMITED WARRANTY & LIABILITY 6.1 Warranty Disclaimer. tinyBuild, including our affiliates, third-party developers, and partners, provide the Licensed Material "AS IS" and on an "AS AVAILABLE" basis. Epic provides the Epic Materials "AS IS" and on an "AS AVAILABLE" basis. We and Epic make no express warranties or guarantees about the Licensed Material or the Epic Materials. TO THE GREATEST EXTENT PERMITTED BY LAW, WE AND EPIC DISCLAIM ALL WARRANTIES, WHETHER EXPRESS OR IMPLIED, INCLUDING MERCHANTABILITY, SATISFACTORY QUALITY, FIT FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT. WE AND EPIC DO NOT GUARANTEE THAT THE LICENSED MATERIAL OR EPIC MATERIALS WILL MEET YOUR REQUIREMENTS, BE ERROR-FREE, OR UNINTERRUPTED. This includes damage to devices or any other damages arising out of or in connection with this Agreement or the Epic Materials, even if caused by our or Epic's fault, tort (including negligence), strict liability, indemnity, product liability, breach of contract, breach of warranty, or otherwise, and even if any remedy fails to provide adequate compensation. If the Licensed Material or Epic Materials damages your device due to our or Epic's lack of reasonable care, we may compensate you or repair your device. INDEMNIFICATION You agree to defend, indemnify, and hold harmless us, our affiliates, and our third-party developers and partners, including their respective employees, contractors, officers, directors, and agents from all liabilities, claims, and expenses, including attorney's fees, which arise from your use or misuse of the Licensed Material. We and our affiliates, third-party developers, and partners reserve the right, at our own expense, to assume the exclusive defense and control of any matter otherwise subject to indemnification by you, in which event you will cooperate with us in asserting any available defenses.

8. DISPUTE RESOLUTION 8.1 Good Faith Attempt. You agree that in the event of a dispute between you and tinyBuild or our affiliates, third-party developers, or partners, you will make a good faith attempt to resolve the dispute informally for at least sixty (60) days before initiating arbitration. Binding Arbitration is defined and provided in our TOU at <https://www.tinybuild.com/tou>. In case of any conflict between this Agreement and the TOU, the provisions of the TOU shall prevail.

8.2 Negotiation and Arbitration. If you and tinyBuild cannot resolve a dispute through informal negotiations within thirty (30) days after receiving a notice of dispute, both parties agree to settle any claim or controversy arising out of this Agreement or the Licensed Material through binding arbitration, following the rules of the American Arbitration Association. The arbitration will take place in King County, Washington. This informal, good faith negotiation will commence upon receipt of written notice from you, provided also that your notice includes your full name and address (as the complaining party); the nature and basis of your claim or dispute sufficiently detailed; and the specific relief you seek.

8.3 Individual Arbitration and Relief. Claims or controversies will be arbitrated individually. The arbitrator cannot alter the terms of this Agreement and may award equitable relief to enforce its terms, provided that it does not interfere with tinyBuild's rights or ability to distribute or exploit the Licensed Material. We each further agree that any arbitration or other cause of action related to this Agreement will be conducted in our individual capacities only and not as a class action or other representative action, and we each expressly waive our right to file a class action or seek relief on a class basis.

8.4 Court Proceedings and Applicable Law. If a court determines that a claim or controversy cannot be settled by

arbitration, both parties agree to bring and maintain such claims in state and federal courts located within King County, Washington. The prevailing party in any action to enforce this Agreement may recover costs and expenses, including reasonable attorney's fees. In connection with any dispute between us, whether in arbitration or otherwise, this Agreement shall be interpreted and bound by the laws of the state of Washington and United States federal law. We each irrevocably consent to the exclusive jurisdiction and venue of state or federal courts in King County, Washington to resolve any claims that are subject to exceptions to the arbitration agreement.

8.5 DMCA Complaints. tinyBuild respects the intellectual property rights of others and complies with the Digital Millennium Copyright Act of 1998 (the "DMCA"), which provides recourse for copyright owners who believe that material appearing on the Internet infringes their rights under U.S. copyright law. Any user who is found to have infringed the rights of tinyBuild, its affiliates, third-party developers, partners, or any third-party, or otherwise violated any intellectual property laws or regulations is subject to immediate suspension and/or termination. You agree to comply with any court judgment or conditions imposed due to such claims, including ceasing use of the Licensed Material if required. If you believe that your work has been violated on our websites or on our services in a way that constitutes copyright infringement, please contact us at support@tinybuild.com.

9. GOVERNING LAW 9.1 Applicable Laws. This Agreement shall be governed by and will be construed in accordance with the laws of, the United States of America and the law of the State of Washington, without regard to choice of law principles.

9.2 Exclusion of International Convention. The application of the United Nations Convention on Contracts for the International Sale of Goods to this Agreement is expressly excluded.

9.3 Canadian Residents. If you are a Canadian resident who has purchased a license to the Licensed Material in Canada, other laws may apply if you choose not to agree to arbitrate. Such laws shall affect this Agreement only to the extent required by such jurisdiction. If such laws apply, the terms and conditions of this Agreement shall be given their maximum effect.

9.4 International Users. Users who access the Licensed Material from outside of the United States and Canada, are responsible for compliance with all applicable local laws.

10. DEFINITIONS "Content" means any artwork or other content asset that tinyBuild makes available for you to access or download through the Epic Marketplace or Licensed Material for your use with the Licensed Material and the Game.

"Editor" means the Deadside specific version of the Unreal Editor that tinyBuild makes available for you to access or download for your use with the Game. The term Editor specifically does not include (i) other versions of the Unreal Editor, (ii) Content, or (iii) the Game.

"Epic" means, depending on the location of your primary residence: a. If you reside in the United States, Epic Games, Inc., a Maryland Corporation having its principal business offices at Box 254, 2474 Walnut Street, Cary, North Carolina, 27518, U.S.A.; or

b. If you reside outside the United States, Epic Games Commerce GmbH, a Swiss company with limited liability

having its principal business offices at Platz 10, 6039 Root D4, Switzerland together with its affiliates.

“Epic Content” means any artwork or other content asset that Epic makes available for you to access or download through the Game or Epic Marketplace for your use with the Game.

“Epic Marketplace” means a digital marketplace maintained by Epic or its affiliates through which, among other things, Epic makes the Editor and certain Epic Content available for use.

“Epic Materials” means the Editor and the Epic Content.

“Intellectual Property Rights” include copyrights, trademarks, service marks, patents, trade secrets, trade dress, logos, and other proprietary rights.

“Licensed Material” means the software and Content provided by tinyBuild. It does not include the Editor or Epic Content, which is made available by Epic under the Unreal Engine End User License Agreement, as supplemented by the terms and conditions of this Agreement.

“Mod” means content designed to be used with the Game to provide a gameplay experience that is customized or otherwise modified from the Game as made available by tinyBuild.

11. GENERAL 11.1 Changes. It is your responsibility to read, understand, and accept this Agreement in connection with your use of the Licensed Material. You acknowledge that we may make changes to this Agreement and to the Licensed Material itself, including its features, functionalities, and content, at any time and at our sole discretion. Such changes may be necessary to improve, enhance, or modify the Licensed Material, or to comply with legal, security, or policy requirements. You agree that your continued use of the Licensed Material after any such changes will constitute your acceptance of the changes. If you do not agree with the changes, you must cease using the Licensed Material.

11.2 Contact Us. If you provide tinyBuild with your email address for any purpose, you agree to receive all notices and communications (“Notices”) from tinyBuild in electronic form at such email address. Delivery of any Notice from tinyBuild is effective when sent to your email address, regardless of whether you actually receive or read the Notice. You agree to send tinyBuild all legal notices, including notices of dispute and/or notices of infringement, to the address below.

11.4 No Waiver. tinyBuild's failure to enforce a provision of this Agreement shall not be construed as a (i) waiver of such provision, or (ii) diminishment of any right to enforce such provisions. Further, tinyBuild may choose to waive enforcement of a provision of this Agreement in a particular instance; however, you are still obligated to comply with that waived provision in the future.

11.5 Force Majeure. tinyBuild shall not be liable for any delay or failure to perform resulting from causes outside the reasonable control of tinyBuild, such as natural disasters, unforeseen intrusions into our cyberspace, war, terrorism, riots, embargoes, acts of civil or military authorities, zombie apocalypse, acts of God, fire, floods,

accidents, strikes, or shortages of transportation facilities, fuel, energy, labor, or materials.

11.6 Survival. Any provisions of this Agreement that by their nature should survive termination shall survive.

11.7 Severability. If any part of this Agreement is determined to be invalid or unenforceable, then that portion shall be severed, and the remainder of this Agreement shall be given full force and effect.

11.8 Non-Transferability. The terms of the Agreement are personal to you, and you are not permitted to assign, sub-license, transfer, or dispose of your rights or obligations under the Agreement.

11.9 Export Restrictions. You agree to comply with all applicable export and import laws, restrictions, and regulations of the United States or any foreign nation. You will not export, re-export, or import the Licensed Material or its documentation in violation of any such restrictions, laws, or regulations, and will not transfer the Licensed Material or its documentation to any foreign national or destination prohibited by such laws without obtaining and complying with requisite government authorization.

11.10 US Government Restricted Rights. The Licensed Material and related documentation are "Commercial Items," as defined at 48 C.F.R. §2.101, consisting of "Commercial Computer Software" and "Commercial Computer Software Documentation," as these terms are used in 48 C.F.R. §12.212 or 48 C.F.R. §227.7202, as applicable. You acknowledge that you entered into this Agreement based solely on the representations and promises expressly stated here. No failure by either party to exercise any right under this Agreement will constitute a waiver of those rights. In case of a conflict between this Agreement and any other terms, this Agreement will prevail.

11.12 Controlling Language. The original language of this Agreement is English even if it may be available in other languages. By clicking "I Agree," you agree that the English version of this Agreement shall control any dispute between you and tinyBuild arising from or related to this Agreement.
